Public Notification: Development of a Pest Management Plan

Pest Management Plan Reference Number: PMP001 Applicant: Teck Coal Limited

As per the British Columbia Integrated Pest Management Act and Integrated Pest Management Regulation, Teck Coal Limited is providing notice of its submission of a draft Pest Management Plan for the purpose of managing noxious weeds and invasive plants, and vegetation on industrial sites. This five-year plan will abide by the principles of integrated pest management within the Pest Management Plan area, including the use of pesticides, and other mechanical, manual and cultural control, where feasible.

The pest management activities will be carried out in the Elk Valley on:

•Mine permitted public lands—public (crown) lands within the permitted active disturbance boundary of Teck's operations north of Sparwood (Line Creek), northeast of Elkford (Fording River) and southeast of Sparwood (Coal Mountain mine).

•Coal tenure licenced public land—which includes areas on public (crown) lands where exploration activities exist outside of the disturbance boundary northeast of Elkford (i.e., exploration roads and trails). (Fording River Extension Project, Road Rehabilitation Project areas in the Fording River valley)

•Teck private lands—specifically for railway or industrial vegetation management on railway right of ways, yards or associated signal or communication facilities, electrical substations, or other industrial facilities at Teck's operations southeast of Sparwood (Coal Mountain mine), adjacent to Sparwood (Elkview), north of Sparwood (Line Creek), northeast of Elkford (Greenhills and Fording River).

The pesticides proposed for use under this plan include the following:
